AGREEMENT TO SCREEN FILM AT THE 2018 SANTA FE INDEPENDENT FILM FESTIVAL  
This agreement is between Santa Fe Independent Film Festival LLC. ("SFIFF") and  
\_\_\_\_\_ ( "Film Maker").

I. AGREEMENT TO SCREEN MOVIE

- i. Film Maker hereby releases \_\_\_\_\_ to be screened at the 2018 Santa Fe Independent Film Festival from October 17-21.
- ii. Film Maker agrees that s/he shall receive no compensation for said screening.
- iii. Film Maker agrees that SFIFF can use still pictures, posters, and short segments of the film for publicity purposes by SFIFF.
- iv. Film Maker acknowledges that s/he retains the right to distribute the material in question.
- v. Film Maker acknowledges s/he has authority to enter into this agreement.

II. DISPUTES.

- i. Any controversy arising out of or relating to this Agreement shall be settled by mandatory arbitration.
- ii. All controversies shall first be submitted to a mutually agreeable mediator.
- iii. If the parties are unable to resolve their differences through mediation, within sixty days from written demand for mediation, the dispute shall be arbitrated.
- iv. The parties shall pick a single mutually agreeable arbitrator.
- v. If the parties cannot agree on a single arbitrator the Chief Judge of the First Judicial District for the County of Santa Fe shall be requested to appoint a single arbitrator.
- vi. The arbitration shall take place in Santa Fe, New Mexico.

- vii. Any award or judgment, including injunctive relief, rendered in arbitration will be final and binding and may be entered and enforced by any court having jurisdiction thereof.
- viii. The cost of mediation shall be borne equally by the parties.
- ix. The non-prevailing party of the arbitration shall pay the attorney fees and costs to the prevailing party of the arbitration.

III. NOTICES.

- i. Any notice under this Agreement shall be in writing and shall be effective when actually delivered in person, or three days after being deposited in the U.S. mail, registered or certified, pre-paid post, and addressed to the party at the address stated in this Agreement, or such other address as either party may designate by written notice to the other.

IV. GOVERNING LAW.

- i. The law governing this Agreement shall be governed by and construed in accordance with the laws of the State of New Mexico.

V. PRESUMPTION.

- i. This Agreement, or any section thereof, shall not be construed against any party due to the fact that said Agreement or section thereof was drafted by said party.

VI. PRIOR AGREEMENTS.

- i. This document is the entire final and complete agreement of the parties and replaces all prior or existing written and oral agreements between the parties or their representatives relating to this Agreement.
